**Regarding the governmental
support of non-state investment
YACONTO Integrated Program**

Dear Vladimir Vladimirovich!

President of YACONTO LLC S.P. Yakunin addressed the «International league for the defense of human dignity and security» with an appeal to support in front of the supreme leadership of Russia the implementation of YACONTO Integrated Program developed by his enterprise for the construction of a «Commercial Black Sea port YACONTO» in Tuapse region of Krasnodar Territory for the transshipment of over 100 million tons of cargo per annum, an establishment of a Tuapse Naval Base as the main point for basing and reparation of Russian Black Sea Fleet ships and a creation of a single infrastructure for both objects. The assessment of this Program has been dragged on for 7 years.

«YACONTO Port», TNB and their single infrastructure are planned to be constructed on the rocky coastal territory of the Shepsie rural district. Extraction of rock will allow creating an artificial bay of size and depth necessary for the TNB water area and hence, solve the problem of founding the main basing point of the Black Sea Fleet.

At the same time, the rock will be effectively used for: expansion of the Black Sea coastline and creation of constructions protecting the bank from erosion; creation of artificial coastal land for the construction of world class sporting facilities and resorts; production of cement out of marl contained in the rock; creation of a new high-speed highway; relocation of the railroad inland from the Black Sea coast; supplying the «Sochi-2014» Winter Olympics construction with raw materials.

Construction of the «YACONTO Port» and the TNB in neighborhood, within 5-7 km of the city of Tuapse with a single production, transport and social infrastructure, will: secure socio-economic development of the Tuapse region, city of Tuapse, Krasnodar Territory and Russia as a whole; solve the problem of

disastrous environmental conditions in Tuapse city; strengthen Russia's security and defense in Azov - Black Sea basin and reassert Russian influence in the Mediterranean sea.

The Program has many significant advantages over other options. It has been studied by the Ministry of Defense of RF and the General Staff of the Armed Forces of Russia and can be taken as a basis. The most significant advantages of the Program manifest in operational and strategic basing and natural and climatic conditions versus the previously proposed plan of the naval base for the Russian Black Sea Fleet.

Commander-in-Chief of Russian Navy, Admiral V.S. Vysotsky believes that the establishment of a naval base is impossible without the construction of a commercial seaport with shared infrastructure.

The Program will solve the environmental problems of Tuapse, the City of Military Glory, coming from an illegal surge of anthropogenic impact on its residential area, solve the problems of the protection of rights and legitimate interests of Russian citizens living in Tuapse city which falls under the Bucharest Convention «On the protection of the Black Sea from pollution» of 21.04.1992, ratified by the order of the Supreme Soviet of Russian Federation № 5614-1 from 12.08.1993 and thereby remove one of the main arguments against the preparation and conduction of XXII Winter Olympics and XI Winter Paralympics in Sochi in 2014.

Dear Vladimir Vladimirovich, we ask you to support the implementation of the non-state investment YACONTO Integrated Program of federal and nationwide significance.


