Regarding an independent investigation  
of a large-scale crime in Russia – bankruptcy  
of Atom mash OJSC.

**To the Prime Minister  
of Russian Federation****V.V. PUTIN****Dear Vladimir Vladimirovich !**

Under your Order of 13.07.2011 ref. №VP-P7-4798, the heads of State Corporation “Rosatom”, Ministry of Economic Development of Russia and the Ministry of Finance of Russia are instructed to ensure the execution of the Order of the President of Russian Federation D.A. Medvedev dated 08.07.2011 ref. №Pr-1948 and provide aligned proposals with a draft report to the President of RF by 22.08.2011.

The reason for YACONTO LLC to address you is an inspection of the bankruptcy and liquidation of Atom mash OJSC (Volgodonsk, Rostov region), where the State owned 30% share, carried out under four Orders of the Russian President: of 29.06.2010 ref. №Pr-1883, of 21.08.2010 ref. №Pr-2448, of 19.05.2011 ref. №Pr-1413 and of 08.07.2011 ref. №Pr-1948.

Concern YACONTO JSC (Russia, Moscow) owned 28.5% stake in Atom mash OJSC, hence, as a result of the premeditated bankruptcy of the Russian nuclear engineering giant, both the State and Concern YACONTO JSC have been illegally deprived of their property.

Being the founder and proprietor of YACONTO LLC (RF, Moscow), which is the full and sole successor of Firm YACONTO SE (LLP), Trade House YACONTO SE and Concern YACONTO JSC, I knew very well what was really happening in Atom mash OJSC.

YACONTO LLC has sent to the General Prosecutor of Russia Y.Y. Chaika: a Complaint (out. №110201-A01 of 01.02.2011), Addendum №1 (out. №110303-A01 of 03.03.2011) and Addendum №2 (out. №110321-A01 of 21.03.2011) to the said Complaint; a Statement (out. №110418-A01 of 18.04.2011), Addendum №1 (out. №110607-A01 of 07.06.2011) and Addendum №2 (out. №110808-A01 of 08.08.2011) to the said Statement. These appeals and documents attached thereto contain irrefutable evidence and facts of anti-state activity of specific officials on federal and regional level under Russian nuclear engineering giant Atom mash OJSC’s bankruptcy and liquidation case.

There are only a handful of companies like the nuclear industry giant Atom mash OJSC in the world. If we consider the matter of Atom mash OJSC's bankruptcy on the merits, it becomes clear that no serious inspections have been conducted by law enforcement and supervisory agencies throughout the period from the point it has been declared bankrupt and liquidated till present time. Moreover, the participants of an organized group of interested officials (OGIO) and an organized criminal group (OCG), utilizing administrative resource and mutual protection on federal and regional level, did all they could to prevent the investigation of Atom mash OJSC's bankruptcy. They blocked literally all inspections – understanding, that those could lead to a major criminal process in Russia with according consequences for OGIO and OCG members. And the State's role in Atom mash OJSC's bankruptcy case has remained somewhat amorphous to date. And that's despite the fact that 30% share in Atom mash has been stolen from the State, and the latter must protect its interests and punish the guilty according to the Law.

YACONTO LLC has developed Project-A, designed to restore the violated rights and interests of the state, society and business. Its implementation will help solve problems and tasks faced by Russia. It will restore the status quo of Atom mash OJSC and bring back 30% of its shares to the State; the guilty party will compensate for the damage dealt; the State will accumulate the controlling stake in Atom mash OJSC through exchanging the 28.5% share owned by YACONTO LLC for agreed property; all payables to third parties will be repaid; the State accumulated property will be transferred to authorized entities to develop of nuclear engineering and implement programs of socio-economical development in Russia. More details about Project-A are set forth on pages 6–8 of the Addendum №2 (out. №110808-A01 of 08.08.2011) to the Statement to the General Prosecutor's Office of Russia (out. №110418-A01 of 18.04.2011).

**I ask you to** instruct the structures of the Government of Russian Federation to ensure the execution of the Order of the President of Russian Federation D.A. Medvedev dated 08.07.2011 ref. №Pr-1948 in the interests of the state, taking into consideration Project-A for the restoration of the status quo of Atom mash OJSC, developed and proposed for implementation by a Russian company YACONTO LLC.
