Dear Sergey Mikhailovich!

YACONTO LLC has been addressed by members of an initiative group of public movements and political parties of Tuapse city "Clean City" (out. № 40 of 14.05.2007), proposing to join forces to implement the non-state investment YACONTO Integrated Program, taking into account the interests of residents of Tuapse city and Tuapse region. The Integrated Program consists of large, promising projects and programs included in the YACONTO List of Projects of 09.05.2005 to be implemented in Russia at the expense of extrabudgetary funding and other Russian and foreign investment resources, which fully corresponds to the Address of the Russian President Vladimir Putin to the Federal Assembly on 26.04.2007.

The Appeal (out. № 36 of 14.05.2007) addressed to you personally, attached to this letter, contains irrefutable evidence of dangerous large-scale violations of human health and environmental standards in Tuapse, which require immediate investigation by federal law enforcement authorities, with the assistance of specialized organizations and under the control of the state leadership. Those violations were made possible by a professional, artful concealment of illegal businesses, merged with corrupt officials who cynically hide behind the state's interests and use administrative resource in their selfish interests. More detailed information about lawlessness of officials has been set forth in previous Letters of YACONTO LLC to you (out. № 1-70416 of 16.04.2007 and out. № 1-70511 of 11.05.2007).

The Appeal supports the YACONTO Integrated Program which includes the construction of a large modern «Commercial Black Sea port YACONTO» («YACONTO Port») for the transshipment of over 100 Million tons of cargo annually and an establishment of a Tuapse Naval Base (TNB) as the main point for deployment and repair

of Russian Black Sea Fleet warships and vessels (including those subject to withdrawal from Ukraine), both said facilities having single industrial, transport and social infrastructure in the Shepsie rural area of Tuapse region of Krasnodar Territory. Besides, significant growth of industrial and agricultural production in the Southern Russia will be secured through the increased efficiency of road, railroad, pipeline, air and water transport; the implementation of the Program will also improve the socio-economic and political situation in the North Caucasus, strengthen the defense capabilities and national security of Russia in the Azov – Black Sea basin.

Members of the initiative group of public movements and political parties of Tuapse city "Clean City", expressing the interests of the citizens of Tuapse city and Tuapse region, suggested that I address you as the Chairman of the Federation Council of the Federal Assembly of Russian Federation and the Leader of the "A Just Russia" political party, asking you to support their Appeal to unite the Tuapse city and Tuapse region, so that problems of the city and the region's development, including the matters of withdrawal of environmentally hazardous facilities from the city, can be reviewed jointly.

I ask you to consider and take appropriate action under the attached Appeal (out. № 36 of 14.05.2007) together with the Letters of YACONTO LLC addressed to you personally earlier (out. № 1-70416 of 16.04.2007 and out. № 1-70511 of 11.05.2007) support the nongovernmental investment YACONTO Integrated Program which has a federal and nationwide significance, before the Russian President – Supreme Commander of the Armed Forces of Russia Vladimir Putin and the Prime Minister of Russia Mikhail Fradkov.
