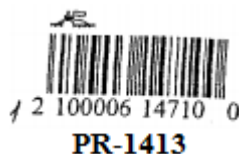

**To the President of Russian Federation
D.A. MEDVEDEV**

Dear Dmitry Anatolyevich!

I addressed you in July 2010 regarding the fate of the unique enterprise - Atommash OJSC (Volgodonsk, Rostov region), the flagship of domestic nuclear engineering where the State owned 30% stake.

In accordance with your Orders the Presidential Control Directorate of RF is conducting a verification of the legal validity of bankruptcy and forced liquidation of Atommash OJSC. General Prosecutor's Office of Russian Federation examines the validity and justification of the previously made decisions not to initiate criminal proceedings on the fact of the bankruptcy of Atommash OJSC, which is especially appropriate as the statute of limitation period for serious anti-state offenses (15 years) has not yet expired.

However, there's a reason to believe that all verifications are merely formalities, as they are conducted by the law enforcement agencies of Rostov region that clearly cover up the anti-state activities of local officials against Atommash OJSC.

As far as we know, the public and Russia's potential foreign investors express interest in the investigation of the bankruptcy of Atommash OJSC.

Still, those who fight for the interests of the State only receive formal, non-committing replies from the law enforcement agencies, despite the fact that nuclear engineering is a strategic area and we are dealing with economical and energy security of the country here.


It appears to be expedient to transfer the conduction of the Atommash OJSC bankruptcy case to federal law enforcement authorities. Only by doing so we can restore the legal rights of the State which has been deprived of its property due to activities of certain officials on regional and federal levels.


