On violation of my Constitutional rights of a Russian Citizen and Proprietor of YACONTO LLC (Russia, Moscow)

## COMPLAINT

Being a Russian Citizen and the Proprietor of YACONTO LLC (Russia, Moscow), on 15.08.2012 I, as the President of YACONTO LLC, once again addressed You personally as Guarantor of the Constitution of Russian Federation, in order to protect my violated rights and my property from unlawful activities of Russian officials and their accomplices, irresponsible before the Law and the State.

For 12 years, in response to YACONTO LLC's justified appeals to the Supreme leadership of Russia, as well as to law enforcement, supervisory and controlling authorities, regarding an investigation of the premeditated bankruptcy of Russia's nuclear engineering flagship Atommash OJSC (Volgodonsk, Rostov region), we received nothing but careless formal replies, the contents of which contradicted each other, contradicted current Laws and the Constitution of Russian Federation.

So far, we haven't received a response for the Statement of YACONTO LLC (out. №120815-A01 of 15.08.2012), addressed to You personally, either. Instead of a reply from You, we received a strange letter (out. №301/23-4686-12 of 05.09.2012, not sent by post until 14.09.2012 and received on 19.09.2012) from the North Caucasian Federal District Headquarters of the Investigative Committee of RF (hereinafter, the Department), addressed to me as an individual, not to the President of YACONTO LLC and a Russian Citizen.

In its Letter, the Department did not specify, which "appeal" in question was being responded to, since the content of the Letter does not correspond to issues set forth in the Statement of YACONTO LLC to You as the Russian President.

The Letter is signed by the Acting Chief of the Third branch of procedure control of the control-forensic Department of the North Caucasian Federal District Headquarters of the Investigative Committee of RF, Major of Justice Gamayunov V.S. (author of the Letter), without any commentary about his authority to speak for the Russian President.

The aforesaid Letter of trivial content is a classic example of a vague bureaucratic "come-off", for which nobody is going to be held liable - liable for apparent inactivity in the situation where professional duty demands protection of the vital interests of the State and Citizens of Russia.

Author of the Letter, acting by orders of the Deputy Chairman of the Investigative Committee of Russian Federation Karnaukhov B.M., groundlessly claims that my "appeal" contains no issues within the competence of the Investigative Committee of RF. On this basis, Major of Justice Gamayunov V.S. delegates the review of the "appeal" to the Russian MoI and the General Prosecutor's Office of Russia and lets them answer the raised questions.

The Letter does not indicate, whom this "nameless appeal" was assigned to, on what basis, and by whom in the Presidential Executive Office. YACONTO LLC has directed its Statement to You personally, but it was taken on by the functionaries of the Presidential Executive Office, whom I as a Russian Citizen do not trust.

At the same time, the Letter does not indicate that the documents published on WWW.YACONTO.COM have been reviewed. Those documents contain sufficient information about criminal activity of specific officials and their accomplices who took part in the intentional bankruptcy of Atommash OJSC and other major Russian companies. They dealt colossal damage to the economic security, defense capability and statehood of Russian Federation. This is why their criminal activity should be meticulously inspected by independent investigative and supervisory agencies.

It follows from the contents of the Letter that its author has not performed the verification of facts set forth in the documents, published on YACONTO LLC's website for International community's information, as he should have done according to job instructions under the Law. Besides, these documents have been deliberately ignored during the quasi-inspections of the facts of unlawful activity of corrupt officials during the bankruptcy of Atommash OJSC, carried out by the law enforcement agencies of Rostov region and never mentioned in the Letter from the Major of Justice Gamayunov V.S.

The Statement of YACONTO LLC (out. №120815-A01 of 15.08.2012) specifies documents exposing facts of anti-state activities of officials and their accomplices, requiring verification by independent law enforcement agencies in order to restore the rule of law in the country on the basis of Russian Constitution.

Among your inner circle, there are officials who are obviously not interested in the investigation of the premeditated bankruptcy of Atommash OJSC, which caused colossal material damage to the State. These "agents" are doing their best to prevent a thorough inspection of the criminal activity of people who participated in the bankruptcy of the nuclear engineering flagship. The formal reply of the Major of Justice Gamayunov V.S. for my "appeal" to the person never spelled out in the text - i.e. to You - is a proof of that.

I ask You to provide an appropriate reply on the merits to the Statement of YACONTO LLC (out. №120815-A01 of 15.08.2012) addressed to You personally and provide legal and administrative evaluation of the Letter from the North Caucasian Federal District Headquarters of the Investigative Committee of RF (out. №301/23-4686-12 of 05.09.2012), and of the very activity of the staff of law enforcement agencies.

Looking forward for Your reply on the merits.
