**Dear Dmitry Anatolyevich !**

**On your 4 Orders:** from 29.06.2010 №Pr-1883, from 21.08.2010 №Pr-2448, from 19.05.2011 №Pr-1413 and from 08.07.2011 №Pr-1948 an investigation of the premeditated bankruptcy and liquidation of Atom mash OJSC (Volgodonsk, Rostov region), national nuclear engineering flagship, where the State owned 30% share, is being conducted.

For 11 years, YACONTO LLC (Russia, Moscow), as the proprietor of 28.5% share in Atom mash OJSC, has been struggling actively to restore - in the interests of the State itself - the latter's rights for 30% interest in Atom mash OJSC, illegally seized from it during the bankruptcy.

YACONTO LLC offers to purchase from the state the 30% share in Atom mash OJSC it used to control, at negotiated price.

**I kindly ask you** to issue an appropriate Power of Attorney to a person authorized to negotiate the purchase of 30% state-owned interest in Atom mash OJSC with YACONTO LLC
