DEAR YURI DMITRIEVICH

This is to let you know that in reply to our appeal to you, the Russian Federal Service for insolvency cases and financial rehabilitation sent a letter №GT-04/3468 of 23.12.1998 signed by Georgy Tal, which contains disinformation; some facts are missing or distorted in the letter.

For my five months as Chairman of the Board of Atommas OJSC (from 08.04.1995 to 07.09.1995) I started a meticulous search for major violations and abuse committed by the company's management. The YACONTO Company, a large shareholder of Atommas by then, initiated an audit of production, economical and financial activity of Atommas. The audit immediately uncovered multiple violations by the executive management: sale of liquid assets and strategically important raw and other materials for a pittance, sale of finished goods at production cost, as well as violations in the usage of the federal targeted loan (1992–1994) which Georgy Tal cunningly (to say the least) describes, hinting at my participation in that. Besides, Georgy Tal, Alfred Koch and Peter Mostovoy themselves took part in the events that I describe in the letter from Concern YACONTO №9-11-PKYA of 09.11.1998. Therefore, I believe that Georgy Tal's reply to our letter cannot be considered unbiased, and requires a thorough double-check with other sources of information.

Understanding that the YACONTO Company is seriously committed to deeply inspect the production, economical and financial activity of Atommas from the moment of its privatization till the moment of my election as Chairman of the Board, the General Director of Atommas Alexey Golovin and people behind him – through deceit, plotting and unrest among the employees they provoked – guided the work of auditing organizations according to a carefully planned scenario, understanding that otherwise they would have to pay for what they've done to Atommas.

Kindly take the above into consideration when verifying the materials mentioned in the letter from Concern YACONTO №9-11-PKYA of 09.11.1998.

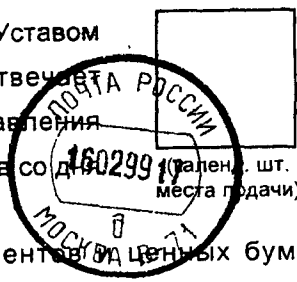

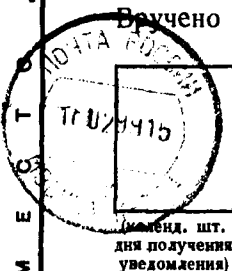

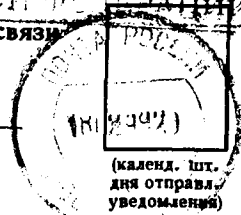
