About the independent investigation of a large-scale crime in Russia, the bankruptcy of Atommash OJSC

To the President of Russian Federation D.A. MEDVEDEV

Dear Dmitry Anatolyevich!

Following your Orders from 29.06.2010 № Pr-1883 and from 21.08.2010 № Pr-2448, the Presidential Control Directorate conducts an investigation of bankruptcy and compulsory liquidation of Atommash OJSC (Volgodonsk, Rostov region), where the State controlled 30% of the shares. In the response from the Presidential Control Directorate to YACONTO LLC from 08.02.2011 № A8-771-5 it is reported that the investigation is being led by the General Prosecutor's Office of Russia.

Concern YACONTO CJSC (Moscow, Russia) owned 28.5% of the shares of Atommash OJSC, so the deliberate and illegal bankruptcy of the flagship company of Russia's nuclear machinery resulted in property loss for both the State and for Concern YACONTO CJSC.

Being the founder and the owner of YACONTO LLC (Russia, Moscow), which is the full and sole successor of Firm YACONTO LLP, Trade House YACONTO SE and Concern YACONTO CJSC, I am fully aware of what was really happening in Atommash OJSC.

Having been the Chairman of the Board of Atommash OJSC, I was able to obtain carefully concealed information on its industrial, economic and financial activity at the time when members of an organized group of interested officials (OGIO) and organized criminal group (OCG) started to carry out their anti-state plan of bankrupting this "plant of the plants" deliberately.

YACONTO LLC has submitted to the General Prosecutor of Russia Y.Y. Chaika a Complaint (out. № 110201-A01 from 01.02.2011), Addendum № 1 (out. № 110303-A01 from 03.03.2011) and Addendum № 2 (out. № 110321-A01 from 21.03.2011) to the said Complaint with thereto attached documents containing a proof of the facts of a deliberate bankruptcy of Atommash OJSC. General Prosecutor's Office of Russia ordered the Prosecutor's Office of Rostov Region to perform a meticulous investigation of validity of the previously made decisions not to initiate criminal cases on the facts of bankruptcy of Atommash OJSC.

However, replies from the Prosecutor's Office of Rostov Region (№ 16-136-10 from 21.03.2011) to YACONTO LLC and (№ 16-136-10 from 31.03.2011) to the Russian State Duma suggest that the investigation of bankruptcy of Atommash OJSC is being performed as a formality. The investigation is being actively opposed on regional and federal levels by the previously mentioned members of

OGIO and OCG who took a part in the events that were described in the Complaint of YACONTO LLC and the respective Addendums. Those people clearly receive help from certain individuals who, according to their duty, are supposed to be protecting the national interests of the State and those of its citizens. Violating the norms of Law and morality, they cover up criminal activities of those who, during the reforms period, destroyed Russia's industry, agriculture and science, inflicting great damage to its economic security, defense and statehood. The investigation of the bankruptcy of Atommash OJSC is being performed by law enforcement agencies of the Rostov region and Volgodonsk city that were formed during the period of V.F. Chub's "ruling" as a Governor of Rostov Region and staffed with people who today are still under his control. This is why, in order to prevent a disruption to the investigation of Atommash OJSC, it is necessary to have those people scrupulously examined on a polygraph by the special services of Russia in Moscow.

Having familiarized itself with the replies from the Prosecutor's Office of Rostov Region, information of which had been borrowed from the Resolutions of the police department of Volgodonsk, Rostov region, on the "refusal to initiate criminal proceedings", YACONTO LLC has submitted a Statement to the General Prosecutor of Russia Y.Y. Chaika (out. №110418-A01 from 18.04.2011), reporting illegal activities of the law-enforcement officers themselves, who are acting in the interest of the said members of OGIO and OGC during the course of investigation of the bankruptcy of Atommash OJSC.

The hunt for the property of the Energomash Group belonging to A.Y. Stepanov indicates that the redistribution of assets in Russia is not yet complete. Commercial loans for his company (and the assets of the former Atommash OJSC) for the implementation of the "declared projects" became the basis for a yet another carving up of assets remaining in Russia from the industrial might of the USSR. Therefore, the arrest of A.Y. Stepanov, approved on 02.02.2011 by the Tverskoy Court of Moscow, was carried out in the interests of the "official elite" for the "business partners" who claim rights for some of Stepanov's companies officially belonging to him. At the same time, his arrest is not related to the bankruptcy of Atommash OJSC that inflicted damage to the State, but rather to the creditor showdowns in favor of individuals who intend to exclusively own the industrial complex that consists of liquid companies of the energy engineering industry. It is no accident that the investigation of the bankruptcy of Atommash OJSC and the creditor squabbles are not brought together into one case which would be contrary to the interests of the "elite".

It is most expedient to transfer the investigation and prosecution of the bankruptcy of Atommash OJSC to Moscow at a special order. The reason for this is to restore the legitimate rights and interests of the State, deprived of its property as a result of anti-state activities of the officials at the regional and federal level.

Instability and deterioration of living standards of the peoples of Russia may lead to social upheaval, and the guilty will not be able to escape the responsibility and inevitability of punishment.

Thus, it is not by accident that foreign investors hesitate to invest in Russian economy like they do in China, as they fear corruption and illegal seizure of business. Only the raw materials export sector of the economy has a chance to attract investments, being safeguarded against risks and hostile takeovers. But this situation is unsustainable and doesn't guarantee national interests and socio-economic development of Russia in general.

In the interests of effective development of high-end energetic engineering in Russia, YACONTO LLC developed the Project-A for restoring the status quo of Atommash OJSC. This Project provides bringing back 30% of Atommash OJSC shares that were expropriated illegally during the bankruptcy and liquidation of Atommash OJSC, to the State. According to the Project-A, the guilty individuals will fully compensate for the damage caused to Atommash OJSC from their own property (assets). After that, the State accumulates a controlling stake in Atommash OJSC and provides full restoration of its productive capacities which are capable of implementing the program of nuclear power development in Russia and abroad. With that, the State transfers the property (assets), obtained through compensation for the damage caused to Atommash OJSC, to an authorized trust management. The purpose of that action is to achieve maximal efficiency from the exploitation of the transferred assets and attract potential investors for joint implementation of promising projects and integrated programs for socio-economic development.

All materials referred to in the Complaint and both Addendums are published on WWW.YACONTO.RU in the folders of different sections to confirm the facts and information provided. The reason for that is the necessity for dispelling the stream of lies and disinformation spread around YACONTO LLC by the members of OGIO and OCG who use all possibilities and media under their control, including the Internet, to discredit YACONTO LLC through information warfare.

I ask you to take the investigation of bankruptcy of Atommash OJSC according to the facts provided in the attached documents under your personal control and protect the rights and legal interests of the State by taking a principal political decision for restoring the status-quo of Atommash OJSC in the interests of its shareholders, of which the State itself was the core one.
