Mr. Michael Anthony McFaul****Your Excellency !**

The Letters from YACONTO LLC (out. №120416-A02 of 16.04.2012 and out. №120705-A01 of 05.07.2012), reviewed by you and the staff of the Embassy of the United States of America in Russian Federation, contain information with a proposal for the U.S. to participate in the promising planetary-scale YACONTO International Program. Such participation can be facilitated by means of Project-A for the restoration of the status quo of the Russian nuclear engineering flagship Atommash OJSC, where YACONTO LLC owned 28.5% stake and the State owned 30% stake.

Prior to the Presidential elections in the United States of America which took place on 06.11.2012 and resulted in Mr. Barack Hussein Obama's confident victory, YACONTO LLC appealed personally to the President of Russian Federation Vladimir Putin with the following reasonable interrelated appeals: a Statement (out. №120815-A01 of 15.08.2012), a Complaint (out. №120924-A01 of 24.09.2012) and another Statement (out. №121009-A01 of 09.10.2012).

The grounds for YACONTO LLC to address the Guarantor of Constitution of Russian Federation were set by continuous violations of my rights as a Citizen of RF and a Proprietor of YACONTO LLC (Russia, Moscow) by Russian officials and their accomplices, which hold no responsibility before the Russian Law and the State. "Mutual protection", created by the Supreme leadership of Russia in state power authorities, would not let me achieve justice and restore my violated rights under the Law of the RF and the Russian Constitution.

Violation of the principles of democratic reforms in Russia has led to a sustainable system of all-inclusive corruption, in which the higher the position occupied by the official, the less administrative, financial and criminal liability to the state and its citizens he has. And the "power elite" in the highest echelon of state power and control in Russia bears no responsibility for anti-state activity whatsoever.

There are "functionaries" in the inner circle of Russian President Vladimir Putin who are disinterested in the investigation of the premeditated bankruptcy of Atommash OJSC. They are doing their best to prevent an inspection of criminal activities of corrupt officials who took part in the bankruptcy of Russia's nuclear engineering flagship.

For 12 years YACONTO LLC has been sending numerous appeals on the fraudulent bankruptcy and forced liquidation of Atommash OJSC to both Russian Presidents and to the Supreme state power bodies. Justified appeals of national importance have been sent to the Presidential Executive Office of RF, Russian Government, Russian State Duma, Russian Federation Council, Russian Ministry of the Interior, Investigative Committee of RF, General Prosecutor's Office of RF, Federal Security Service of RF. And for 12 years we have been receiving nothing but careless come-offs, contents of which clearly contradicted each other and were contrary to current Laws and Constitution of Russian Federation.

In order to prevent the investigation of the premeditated bankruptcy and liquidation of Atommash OJSC, corrupt officials illegally utilize law enforcement, supervisory, controlling

and judicial authorities for their own benefit. Hence, restoration of the status quo of Atomash OJSC is practically impossible without a direct order from the Russian President Vladimir Putin. Unfortunately, I have no reason to count on the participation of the Guarantor of Russian Constitution in the restoration of my violated rights of the Russian Citizen and Proprietor of YACONTO LLC. High-ranking officials and their abettors have put themselves above the Russian Law, utilizing their “immunity” in their lawless activity.

If the Project-A is disrupted by Russian corrupt officials, acting in the interests of the “ruling elite” and their business partners, YACONTO LLC will be forced to start implementation of the Project-B – without Russia. Implementation of this Project includes seizure and confiscation of foreign property (assets), illegally obtained by Russian corrupt officials, according to the “YACONTO List” provided for integration into the “Magnitsky List”. All information about Project-B is completely classified from the “Russian ruling elite” and their accomplices, aside from having been mentioned in the Statements of YACONTO LLC to the Russian President Vladimir Putin (out. №120815-A01 of 15.08.2012 and out. №121009-A01 of 09.10.2012), published by me on [www.yaonto.com](http://www.yaonto.com) for the information of the International community and the public.

The “uncompromising struggle against corruption” in Russia is promoted in order to divert attention from very large anti-state crimes. Supreme leadership of Russia itself is interested in concealing information about them and prevention of according investigations. Thus, this “struggle” is highly selective. This “struggle” is primarily aimed at officials and their associates, whose criminal activity went “out of control” of Russia’s Supreme leadership. Besides, they need to “sacrifice” someone to the Russian nation every now and then, in order to avoid finding themselves on the victim’s place.

Having said the above, I intend to appeal to those who are very interested in exposing specific corrupt officials in Russia and including them into the “Magnitsky List”. International investigations of their criminal activity against me as a Russian Citizen and Proprietor of YACONTO LLC are required, followed by fair decisions made by independent international Courts and Tribunals, with arrests and confiscations of property illegally obtained by corrupt officials in different States of the world, in my favor as the aggrieved party. I expect that it will also affect the assets of their family members, agents, and third (dummy) parties, to whom this property was assigned and re-assigned in a chain in order to obscure its movements and hide the crime. I hope that Western intelligence agencies have the necessary knowledge base and experience of disclosure of such crimes.

**Your Excellency, I kindly ask you for a personal meeting at the time that suits so I can provide confidential information about the Project-A and Project-B so that this information can be conveyed to the U.S. President Mr. Barack Hussein Obama.**
