Dear David,

Thank you for your letter dated August 12, 2011 with five presentations of United Space Alliance assets. I studied them attentively.

I think that US unique capabilities in space research and technology should be maintained. Thus it is extremely important to load up scientific and industrial institutions which were engaged in design, production and exploitation of air and space devices. You shouldn't let these great achievements which belong to all mankind be eliminated as it took place in Russia despite of powerful research and industrial potential.

Advanced technologies used in US space industry could be engaged effectively in many spheres in Russia and other potential partner states.

As you may know YACONTO LLC (Moscow, Russia) prepares global scale multibranch YACONTO International Program. It comprises prospective projects and programs designed for a number of states interested in a stable growth of their economy.

YACONTO International program also comprises a rehabilitation of the Russian nuclear industry flagship - Atommash OJSC (Volgodonsk, Rostov region). Russian Government used to hold 30% of its shares which were lost because of a intentional bankruptcy in 1995-1999. This bankruptcy became possible only because of participation of corrupted officials.

Concern YACONTO CJSC (Moscow, Russia) used to be an owner of 28,5% Atommash OJSC, thus as a result of Atommash intentional bankruptcy Concern had illegally lost its property like Russian Government.

As a founder and an owner of YACONTO LLC (Moscow, Russia) which is full and the only legal successor of YACONTO Small Enterprise, YACONTO Trade House, Concern YACONTO CJSC I am well aware of what was going on in Atommash OJSC.

On July 13, 2011 Russian Prime Minister Putin has issued instructions No. VP-P7-4798 to the heads of Rosatom State Corporation, Ministry of Economic Development and Ministry of Finance to provide implementation of President Medvedev's order No. Pr-1948 dd July 08, 2011 and present coordinated proposals along with draft report to President by August 22, 2011. Atommash OJSC issue used to be a topic of 4 (four) orders made by the Head of State.

YACONTO LLC has designed Project-A to restore violated rights and interests of Russian Government, society and business circles. The implementation of this project will make it possible to solve many problems which stay before Russia and its partners, to restore status quo in Atommash OJSC, to bring back 30% shares to the Government, to compensate damage in account of guilty persons. As a result Government will accumulate control over Atommash OJSC shares and exchange YACONTO LLC's 28,5% shares to investment assets. Besides that Government will pay Atommash OJSC debts to the third parties and will hand over accumulated properties to the appropriate trust managers who are in charge of atomic industry development in Russia and its partner states. Support to Project-A will help to provide favorable conditions for the implementation of YACONTO International Program which comprise multibranch development of energy resources, transportation, space, medicine, bio-technologies, etc.

Project-A provides the growth of Government's participation in Atommash OJSC up to full control by buying YACONTO LLC's shares. The payment for these shares could be agreed with YACONTO LLC in a form of handing over land, buildings, factories, companies, security papers, money and other assets and means in coordination with investors and partners. Some of these investors could be US companies.

On the basis of properties received by YACONTO LLC from the Government as a result of implementation of Project-A I plan to establish YACONTO OJSC with the participation of investors and partners. Along with this process we could use new methods of financial know-hows which will let implement YACONTO International Program in a quick and effective manner.

Unfortunately it is normal in Russia that rule and law violations take place. Thus the fate of Project-A oriented on restoration of status quo in Atommash OJSC in interests of thousands share holders (the main is Government itself) depends on personal position, political will and decision of President Medvedev and Prime Minister Putin.
