On the participation of the Republic of KAZAKHSTAN in the YACONTO International Program To the Ambassador Extraordinary and Plenipotentiary of the Republic of Kazakhstan in Russian Federation

Your Excellency!

YACONTO LLC (Russia, Moscow) addresses Kazakhstan with a proposal to actively participate in the implementation of the YACONTO International Program which is aimed at accelerated, comprehensive socio-economic development of countries on long-term mutually beneficial conditions.

The YACONTO International Program will attract financial and other assets to the development of real sectors of economies of countries-participants, secured by hydrocarbons of the exporters to be returned at time and in volumes agreed between the parties concerned. At the same time, states that are consumers of financial and material resources will also be provided netting services with entities which are not among the participants of the Program. Implementation of the YACONTO International Program will release the economies of its members from dependence on, and pressure from the "Russian monopolists" on exporters, transporters and consumers of hydrocarbons.

The YACONTO International Program will exclude participation of "Russian monopolists" who, through the Russian Government, have brought the country's economy to a catastrophic situation. The reason for this was the merging of the "ruling elite" with the "monopoly business partners" which caused great damage - and not only to Russia - for which none of the "officials" was punished by Law.

One example of sheer lawlessness over seizure and carving up of Russia's remaining assets by the "bureaucracy elite" for the benefit of their "monopoly business partners" is the planned attempt to capture the industrial complex that used to belong to the Russian nuclear engineering flagship Atommash OJSC which was forcibly bankrupted by the organized group of interested officials (OGIO) and the organized crime group (OCG). Russian President D.A. Medvedev has already issued as much as "four orders", the execution of which is sabotaged by the OGIO and OCG members. Persons who bankrupted Atommash OJSC have also committed a fraud with a \$365 million loan taken in the Kazakh BTA Bank. Not just the enterprises, but also scientific and technical researches, projects and programs - in other words, intellectual property - is subject to seizure and redistribution in Russia.

The YACONTO International Program provides for the development of various sectors of the economy of its participants, including energy, transport and space based on the achievements of science and production of the world. More detailed information can be found on: WWW.YACONTO.RU.

Asian, African, European, North and Latin American, Middle East countries and the former USSR republics (currently independent states) will take part in the YACONTO Integrated Program. The Program envisions active participation in the construction of a new navigable waterway 45 - 60 km long in Turkey, parallel to the existing, extremely busy thoroughfare of Bosphorus, the Sea of Marmara and the Dardanelles Strait, for the expansion of economic activity of the Azov-Black Sea basin states.

Kazakhstan's participation in the YACONTO International Program opens wide opportunities and great potential to your country, which has no direct access to the seas and oceans of the world.

In order to implement the YACONTO International Program, its potential participants must take a political decision to provide administrative support to the Program on highest governmental level.

Your Excellency, I ask you for a personal meeting at the time that suits you, so that I can provide confidential information in the interests of socio-economic development of the KAZAKHSTAN Republic and so that you can convey this information to the country's President, Nazarbaev Nursultan Abishevich.
