Mr. Michael Anthony McFaul****Your Excellency !**

YACONTO LLC (Russia, Moscow) received an email from Mr. Wesley Ryan Neuman of the Economic Department of the Embassy of the United States of America in Moscow in response to the letter of YACONTO LLC (out. №120416-A02 dated 16.04.2012) that we have previously sent to you. The reply indicates that the U.S. Embassy has familiarized itself with the contents of my letter and documents attached thereto. The content of the reply from the U.S. Embassy gives grounds for providing more information on the topics raised in the previous letter of YACONTO LLC with the following comment.

The letter of YACONTO LLC (out. №120416-A02 dated 16.04.2012) informs about the unprecedented planetary-scale YACONTO International Program with a value of 1.3 trillion U.S. dollars which is being prepared for implementation. It incorporates interrelated economical projects and programs. The YACONTO Integrated Program for the construction of a modern “Commercial Black Sea port YACONTO” with respective infrastructure in Tuapse region of Krasnodar Territory is merely a part of the multidisciplinary YACONTO International Program.

The aforementioned letter of YACONTO LLC and the set of documents on the bankruptcy of Atom mash OJSC attached thereto have been passed to the United States of America via the U.S. Embassy in Moscow in order to inform you about multiple grave violations of law in Russia’s politics and economy, and in particular, against me as a Russian citizen and against my property which was illegally seized through intentional bankruptcies of industrial companies.

With every reason to fear persecution and revenge from Russian corrupt officials and their accomplices for my principled position and concerted action for returning the illegally seized property of YACONTO companies, in year 2000 I made a decision to suspend economic activity so that those criminals in power had no pretext to forge a criminal case against me and throw me in jail or “send to a better world”. This is exactly why the activity of YACONTO LLC today is limited to development of long-term nongovernmental projects and programs that will be triggered immediately, with the involvement of parties concerned, after a positive decision on my property issues is made.

As a Russian citizen and the proprietor of YACONTO LLC I have every reason not to consider myself protected by rights declared in the Constitution of Russian Federation. In order to fight the lawless mayhem and to restore my legal rights I, as a Russian citizen, need to employ powers enjoyed by international organizations, including international Courts and Tribunals, which are independent from Russia’s ruling elite and its supporters who act only for the benefit of the supreme leadership of Russian Federation and their monopoly business partners. The above is the legal basis for the international law enforcement system to conduct an independent, impartial investigation of the premeditated bankruptcy and liquidation of Russia’s nuclear engineering flagship Atom mash OJSC in order to return its assets to the respective

proprietors and, in parallel, to conduct a meticulous investigation of the criminal activities of high-ranking corrupt officials involved in this biggest anti-state crime in Russia.

I have no doubt that the international investigation will result in an imposition of a fair decision in favor of the victims of the violation of Russian laws, primarily – myself as a Russian citizen and the proprietor of YACONTO LLC and Russia itself as a State. Property belonging to the defendants, including assets in Russia and on the territories of other states of the international community, can serve as a compensation for enormous material and moral damage dealt to the injured party.

I hope that, with support from international organizations, I can protect my rights as a Russian citizen and ensure a strict punishment for corrupt officials who obtained above-the-law authority in Russia and therefore are unaccountable before the Law – regardless of their rank, status and position, as well as for their accomplices who act on behalf of their monopoly business partners.

YACONTO LLC has sent to the Federal Agency for State Property Management (Rosimuschestvo) two Statements (out. №120614-A01 of 14.06.2012 and out. №120702-A01 of 02.07.2012). Protection of Russia's legitimate interests and rights over state property management is within the area of responsibility of the Rosimuschestvo. In those Statements YACONTO LLC proposes the implementation of the Project-A which can restore the rights of the proprietors of Atom mash OJSC, main shareholders of which were the State itself and YACONTO LLC (as the legal successor of Concern YACONTO JSC). However, I cannot be sure that Rosimuschestvo will be allowed to restore the rule of law in respect of the state and YACONTO LLC, since the entire state bureaucratic machine works within a rigid framework of "mutual responsibility" that goes back to the supreme leadership of Russia.

Having said that, I believe that only the international community can force Russian officials to respect international law and impose full administrative, financial and criminal penalties on the officials found guilty of crimes committed against me and YACONTO LLC.

After my rights as a Russian citizen and the Proprietor of YACONTO LLC are restored with the assistance of the international community, all our activities jointly with the potential investors and strategic partners will be immediately aimed at the implementation of highly efficient economic projects and programs included in the multidisciplinary YACONTO International Program.

Your Excellency, I respectfully ask you for a personal meeting at the time that suits you, so I can provide strictly confidential information about the possibilities and conditions of the implementation of the YACONTO International Program so that this information can be conveyed to the U.S. President Mr. Barack Hussein Obama.
