Dear Vladimir,

1. Visit of our delagation to UAE is planned to take place in January 1997 aimed to sing concrete agreemeents about delivery of the products wich were sugested before.

2. We are planned this visit as folowing:

2.1. I and my assistant Andrey Vazhnov will arrive to Dubai for 4-5 days before coming of the specialist with purpose to make clear our joint business and aproaching results.

2.2. Then Mr. Koriykov and plenipotentiary specialist will arrive to the UAE from Russia for 3 days period. They will bring with them special devices for demonstration and familiarization in detail. Demonstration should be confidential without publicity and participation of other foreing specilists. After completion of the mission specialist will return to Russia.

2.2.3. For the transfer of the devices trough the Dubai International Airport you should adjust a permission from customs of the OAE.

2.3. Then our delegation including Mr.Yakunine, Mr.Vazhnov, Mr.Koriykov, Dr. Troikalo and Dr. Nimer and his chief will go to the Dry Land for meetings with Leaders of the country and Government for finish work at the agreement about construction of the desalination plant. Then after 2-3 days to the Dry Land will arrive from Russia one of leaders of the Desalination plant Project. Our staying in the Dry Land should include constractive and substantial meetings for operative work at the agreement about construction of the desalination plant, coordintion sum of the agreement and profit for our mediators.

3. I want to inform you that after return to Russia(after my last visit to UAE) I held series of the meetings with Leaders of Russian Space Agency(RSA) where we reached positive and constructive results. Correspondence which I am sending to you testifies my previos words and it can be used only in case of great interest from side of State channels of Arabic World(without any smal fish) we have to consider interests of our countries, Concern YACONTO and respectable mediators.

3.1. We have to consider material interests of Concern YACONTO which we discuss with you later(this information is strictly confidential and must be kept in secret).

3.2. You have to continue meetings with bussiness competent and influential persons who are interested in construction of the small complex for launch of comercial rockets and satellites aimed to extract profit from it in the field of connection, advertisment, television, meteorology and str.

3.3. We should to define interested sides and circle of the interests and goals which we have to reach and a sources of financion for our joint programmes. We shouldn't forget about "Lady from a Palace" and about your last visit imediatly after we left for Russia.

4. With help of Dr. Nimer's chief you should find out information interested for us for begining of the business and constructive negotiations, for preporation to the sing of the agreemeents about producing and selling of the antimissiles systems surface based which were talking about during our last visit to the UAE. I remind you that this systems can be based(fixed) on hotels, building and palaces roofs, bridges, different plants, petrol and gas stations and on other places.

You have to find out urgent:

- 4.1. List of missions which can be solved by our sysyem
- 4.2. Main specifictions
- 4.3. System of power source
- 4.4. Peculiarities which want to know Customer
- 4.5. Camouflage

5. Also we send you model of the new device-night viewer for advertisment purpose and realisation in the interested Arabic regions and other countries and if it possible by big batchs for army, custom and police.


I ask you to pay aspecial attention to techical description of the night viewer and to the terms of using. Don't move the objective to the direct light.
