The Interdepartmental Committee for the allocation of productive forces in the Tuapse region of Krasnodar Territory has received a Statement of a Moscow enterprise YACONTO LLC (out. № 2-21209 from 09.12.2002) with a Declaration (Petition) of an intent to build «Commercial Black Sea Port YACONTO» in the Tuapse region, between railway stations “Vesna” and “Yuzhni”, Explanatory Note and Scheme of the general plan of the «YACONTO Port» from November 12th, 2002.

REVIEWED:

the presentations by YACONTO LLC representatives regarding the content of YACONTO investment Program for the construction of «Commercial Black Sea Port YACONTO» with all infrastructure required for normal operations of the Port, its production and residential area, in the Tuapse region. Representatives

of YACONTO LLC replied to the questions of the Interdepartmental Committee members and clarified that the said Program is a part of the YACONTO Integrated Program aimed at socio-economic development of Krasnodar Territory and the Southern Russia as a whole, and will be facilitated through the attraction of non-state investments.

The Interdepartmental Committee has reviewed the set of documents of YACONTO LLC, presented for an alignment on the Declaration of November 12th, 2002, and a resolution from concerned authorities and organizations of Tuapse region on the expediency of building the «Commercial Black Sea Port YACONTO» with respective infrastructure on the requested territory and

DECIDED:

to align on the Declaration (Petition) of November 12th, 2002; agree that the construction of the «Commercial Black Sea Port YACONTO» with respective infrastructure in Tuapse region, between railway stations “Vesna” and “Yuzhni” is expedient and in line with the interests of the socio-economic development of the region; propose that YACONTO LLC provides funding for the development of technical project and implementation of the project in general by the means of attracting non-state investments.

During the development of the technical project of «Commercial Black Sea Port YACONTO» it is expedient to pay attention to possible changes in the environmental conditions in the region of planned construction, including changes in ocean currents, impact on the aquatic environment and the recreation area of Shepsie village and implement the recommendations of concerned authorities and organizations of Tuapse region.
