I send you a duplicate of a CD of YACONTO from 20.08.2007 (containing 3190 files in 205 folders), which has not been attached to the documents received by the Ministry of Internal Affairs of Russia from the General Prosecutor's Office of Russia for the verification of facts described in my letter to the Prime Minister of Russia M.E. Fradkov (out. № 1-70820 from 20.08.2007). The letter with an appeal has been sent by the deputy Chairman of Committee of the State Duma for constitutional legislation and State building A.N. Kharitonov (out. № KHAN-1600/GD from 20.08.2007). The YACONTO CD disk of 20.08.2007 contains documents which can provide answers to many questions which potentially can arise during the verification of facts indicated in the said letter.

I presume that those in the Executive Office of the Russian Government who prepared the cover letter (out. № P9-24112 from 23.08.2007) signed by the Director of sectoral development of Russian Government O.S. Pushkareva, deliberately didn't enclose the duplicates of the YACONTO CD of 20.08.2007 to the communication to the Federal bodies of governmental and executive power (according to the list).

Deputy Director of the Department of sectoral development of Russian Government V.I. Ampilogov has complete information on the situation around the non-state investment YACONTO Integrated Program, because as early as in April 2004 I presented to him as Head of the Department of industrial infrastructure and construction of the Russian Government a set documents and gave a detailed explanation (out. № 5-40412 from 12.04.2004, still left unanswered to date). I think that V.I. Ampilogov influences the Executive Office of Russian Government in order to counter the implementation of the YACONTO Integrated Program.
