STATEMENT

Under the Contract on the transfer of scientific and technical products № 13-7-DYA from 13.07.1992 Firm YACONTO SE (Moscow) has transferred design documentation (hereinafter DD) on the multi-purpose woodcarving machine "YACONTO DK-1" to PO "ATOMMASH" (Volgodonsk). Under Contracts № 17-02-DYA from 17.02.1993 and № 98/820-93 from 15.04.1993, Firm YACONTO LLP (successor of Firm YACON-TO SE) transferred to PO ATOMMASH the complete DD for Biomass Energy Units "BEU-10" for its adaptation to production conditions.

YACONTO enterprises of Moscow appealed to S.V. Chesskiy, the bankruptcy trustee of ATOMMASH OJSC numerous times, demanding to return the previously mentioned DD, but never received any reply.

All scientific and technical products (STP) mentioned in the Statement is the property of Firm YACONTO LLP and is patented by "ROSPATENT". The total cost of STP exceeds \$35'000'000 (thirty-five million U.S. dollars). "BEU-10" has significant value for the maintenance of environment, energy saving, development of agriculture and the economy of Russia, as well as in foreign trade turnover.

In order to avoid abuse, I ask you to organize the verification of the facts set forth in the Statement and institute criminal proceedings against the offenders.
